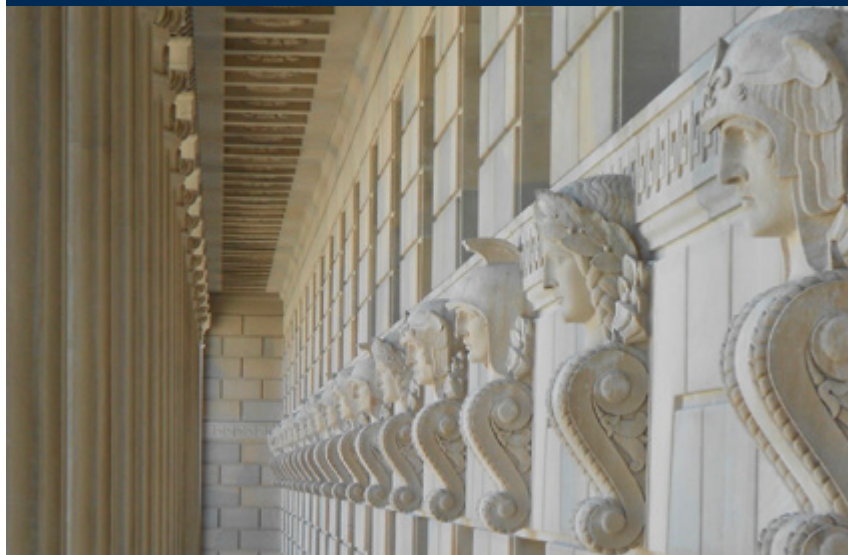

Jim Klein Leads as Washington Building Congress Hits 75th Year Milestone

75th Chairman Looking to Ensure Stable Future

As the Washington Building Congress hits a monumental year, the 2012-2013 Washington Building Congress (WBC) Chairman and vice president of the JBG Companies Jim Klein will focus the 75th year on evaluation and collaboration to carry the organization forward.

Born and raised in New York City, Klein's career in the construction industry started young. He attended a vocational high school and worked in the sheet metal trade at nights and weekends. Following his military commitment in Viet Nam, college, and trade schooling, he entered into heating and air conditioning business, and stayed in the industry for about ten years. After much success, Klein became an entrepreneur when he opened and operated his own commercial HVAC company for a few years.

Klein went on to become senior project manager at Morse/Diesel, Inc., then assistant vice president with Bovis Lend Lease. He coordinated projects for many years including museums, skilled nursing facilities, office buildings, residential high rise, and various college campus buildings, totaling over a billion dollars of work in place.

In 2000, during his time at Bovis Lend Lease, Klein made the move to Washington, D.C. to help direct the Georgetown Incinerator, head up 400 Mass Ave. and the Smithsonian Institution's National Museum of the American Indian.

Chairman Profile

Klein began with his current employer, The JBG Companies in 2005 as a construction manager and eventually was promoted to vice president. He has been responsible for planning and construction such prominent Washington, D.C. area projects such as L'Enfant Plaza, Silver Spring Gateway, 300 New Jersey, and Rosslyn Central Place.

During his time in New York, Klein first got involved with the Building Congress and joined Washington Building Congress within a year of moving to the metropolitan area.

"I really wanted to get involved in a trade industry group. This one fit my personality and views on the industry the best," Klein said. "I connected with the Building Congress because the group helps not only major construction companies, but sub-contractors, suppliers, architects, engineers, lawyers and accountants improve communication and become better educated."


He has since been actively involved for ten years. Throughout his organization participation, Klein has held positions of vice-chair and chair of the programs and education committee, Board Director in 2006, marketing and communications committee liaison, vice-chair of the board and now chairman of the board.

His goals as chairman are; make the right decisions that lead to a stable future, be fiscally responsible and build even more committee collaboration. He said "My big goal is to evaluate everything we're doing, see what's running well, make tweaks, and make it run better. If it's not broke, we shouldn't fix it, but reevaluate and make sure it is the right thing for the future. Now is the time to fine tune the broad picture and implement our ideas properly."

Klein hit the ground running this year by starting planning work in July and August. He filled all committee chair and vice-chair positions, set the Board of Directors meeting dates for the year, and conducted a Board of Directors meeting within two weeks of taking office that focused on ideas for a 75th anniversary celebration. He also set the board of Governors meeting dates, helped coordinate the speakers, restructured the Board of Governors appointee list and populated it with additional people active in the industry.

For Klein, being fiscally responsible means balancing the operations of a non-profit organization, while not charging too much for events and programs the WBC holds. His goal is to keep the events as accessible to members as possible. He also hopes to build committee collaboration as the WBC's Sustainability Taskforce becomes a committee this year and the new Small Business Committee begins work.

Klein has been married for 40 years and has three daughters, two grandchildren, and one on the way. In his spare time, he enjoys playing golf with his son-in-laws, working with his hands, and building furniture, especially toy chests and airplanes for his grandsons.

"One personal objective is getting people to talk to each other, negotiate openly and come to an understanding," Klein said. "I'm looking forward to a great year at WBC and hope to grow our membership and make everyone more collaborative. I'm very respectful and very proud of our organization, and honored to be chairman."

A&A Transfer Providing Additional Services at Aberdeen Proving Grounds

As **Aberdeen Proving Grounds** continues to transform into a high tech C4ISR Center of Excellence, many of the existing micro and macro artifacts that have been on display to the public are being shipped to other US Army locations throughout the US. These have all been part of a collection that supported the Ordinance School and Ordinance Museum formerly headquartered at APG.

A&A Transfer along with partner Meadowlark Transportation has once again been selected by the US Army-Surface Deployment and Distribution Command to transport many of the remaining artifacts to the following Army Garrisons; Anniston, Al., Ft. Benning, Ga., Ft. Lee, Va., Ft. Sill, Ok. and Wright Patterson AFB, Oh.

There are tanks and armored guns that are pre-WWII and require additional attention when rigging onto the various sized flatbeds needed for transport. The mechanized equipment in most instances no longer have their engines making them totally static. A&A Transfer cranes are required to go onto the grass display field, pick the units up, place them properly on flatbeds, securing them in order for the trucks to leave the APG facility. Much of the equipment is over-dimensional and over-weight, requiring the trucks to obtain special permits to operate in every state the equipment passes through. This project will take over 120 truckloads and require the professional services of A&A Transfer crews four weeks to complete.

Heery International has been awarded a third consecutive contract

with **Northern Virginia Community College (NVCC)** to manage construction activities at the school's six campuses.

The latest assignment for Heery involves up to \$40 million in upgrades and enhancements to NVCC facilities, including renovations to classrooms, laboratories, theaters and performance areas, faculty and administrative offices, dining and food-service facilities, elevators, roofing replacements, building envelope remediation, structural repairs, utility relocations, roadway additions and improvements, and landscaping. There will also be upgrades to computing rooms, telecommunications infrastructure, mechanical systems, and fire alarm and emergency alert warning systems.

The Heery team has worked with NVCC since 2001, and the new contract will take the project team through 2017. Over the past 11 years, Heery has contributed to the completion of more than \$175 million in new and renovated facilities and infrastructure improvements on all six campuses, working on 48 buildings totaling 1.6 million square feet.

SIGAL Construction Corporation has been selected to construct the new **Carlos Rosario Annex** in Washington, D.C. for Community Capital Corporation.

Designed by **Shinberg Levinas**, the 48,000 gross square-foot adult education charter school consists of three stories above grade and one level below grade. The structure will be cast-in-place concrete to grade level with a structural steel frame above. The building façade, a mixture of EIFS, glass and curtain wall with exterior thin-set tiling will

create a modern feel to the facility.

The Carlos Rosario Annex will offer an array of classes within award-winning adult education programs, which are considered models at the national and international level. Courses will be taught by a distinguished faculty to include forty-two educators with advanced degrees and educational training. Class options will range from basic english and life skills necessary for successful introduction to American life, to career level english and professional certificate courses in technology and culinary arts. LEED® Gold level certification is targeted for the project, with delivery set for summer 2013.

SIGAL Construction Corporation is renovating and upgrading a significant portion of the stately historic **McKinley Building for American University**. The cornerstone of the McKinley Building was laid by President Theodore Roosevelt in 1902. The McKinley Building, a symbol of the University's early days, will be brought into the twenty-first century in a manner that is both environmentally sustainable and historically sound.

Integration of the buildings historic elements with bold new construction will enhance the School of Communications converged approach to education. The project will include turning attic space into modern classrooms and offices by adding new clerestory windows in the existing facade. Additionally, a green roof, new roof terrace, media innovation lab, a 150-seat theater for public forums and exhibitions, new MEP systems, two new elevators and a glass and metal panel curtain wall on the north and west elevations of the addition will be part of the project. Finally, a portion of the existing stone will be removed and re-used on the addition and one of the new stairs. The state-of-the-art facility will more than triple the current space of the School of Communication. Embracing American University's commitment to environmental sustainability, a LEED® Silver certification is targeted for the project with delivery slated for fall 2013.

tion projects, has increased its presence in the higher education market with the addition of two new buildings at American University (AU). The firm will provide construction management services for the 122,000 square-foot "North Hall" and construct the 53,400 square-foot "**Nebraska Hall Addition.**" These new residences will significantly expand AU's inventory of student housing options with 358 suite-style beds at North Hall and 152 apartment-style beds at Nebraska Hall.

"North Hall" is an L-shaped plan with an eight-story wing and a seven-story wing using post tensioned concrete slabs. It is located adjacent to the President's Office Building. A precast and glass curtain wall will wrap the building facade. The project is valued at \$27.6 million. The "Nebraska Hall Addition" will be a mirror image of the existing Nebraska Hall residence. It will be a four-story concrete structure with three floors of pre-tensioned hollow core

plank slabs. The building envelope will be clad in brick and precast concrete. The contract is valued at \$11.8 million. Both projects are scheduled for completion in the summer of 2013 and will seek LEED NC 2.0 Gold certification.

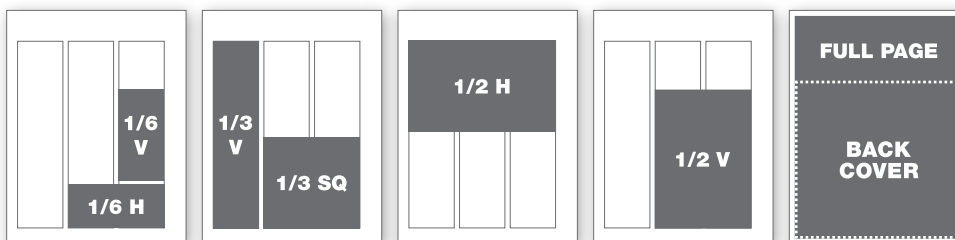
